## A: Summary: What every User Group member should know about SAP **Cloud Platform**

SAP Cloud Platform (SAP CP) is the integration and extension platform for SAP and a key pillar of the Business Technology Platform. Meanwhile it has been sold to more than 15,000 customers and more than 1,000 partners are providing solutions and services on or for the platform.

SAP CP has a considerable set of 300+ services (aggregated into 60 commercially services, delivering full releases every two weeks), ranging from development and operations, integration, workflow, UX, mobile, security, data management and Machine Learning, Internet of Things to a set of business services like tax calculation, currency conversions, consent framework (GDPR). It comes with a common SAP API Business Hub (api.sap.com) hosting several hundred APIs for all SAP solutions and offers a digital marketplace for Cloud Creditbased/Pay-per-use consumption of platform services.

The SAP Cloud Platform evolved its strategy at the beginning of 2019 to focus on being the integration and extensions platform for SAP. It has simplified its messaging and scope on multiple levels, whilst maintaining and improving stability and availability. 2020 will see an increased focus on our integration and extension suite offerings infused with intelligence and backed by a strong multi-cloud foundation.

  - SAP now has well-established Cloud infrastructure and accelerators (such as rapid application development tools)
  - There is a world-wide drive for inexpensive / free, high-quality broadband (think 5G and a bunch of satellites already in orbit), which would pretty much eliminate connectivity constraints

It is imperative to cater for multiple audiences, not everyone is a core developer. We hope to offer very soon a no-code option of SAP Cloud Platform for citizen developers, entrepreneurs who want to explore different avenues.
